As a further update, I wish to inform you that the composite scheme of amalgamation and arrangement ("**Scheme**") to be filed with the Honorable National Company Law Tribunal, Chennai Bench ("**NCLT**") involving, *inter alia*, T V Sundram Iyengar & Sons Private Limited ("**TVSS**"), Sundaram Industries Private Limited ("**SIPL**"), Southern Roadways Private Limited ("**SRW**") (TVSS, SIPL and SRW hereinafter collectively referred to as the "**TVS Holding Companies**"), TVS Investments Private Limited and Geeyes Family Holdings Private Limited was approved by the respective board of directors of the TVS Holding Companies, TVS Investments Private Limited and Geeyes Family Holdings Private Limited on January 30, 2021. The Scheme, together with the necessary documents, will be filed with the NCLT soon.
