UPDATE ON THE UNAUDITED FINANCIAL RESULTS - Q3- FY-2019-20

Chennai, February 08, 2020: TVS Electronics Limited (NSE: TVSELECT) the Chennai headquartered company has declared its financial results for the quarter ended December 31, 2019.

Financial Highlights :

Revenue from Products & Solutions segment was Rs 39.9 Cr during the reported quarter, while revenue from Customer Support Services segment was Rs. 23.0 Cr. The combined revenue from these segments were Rs. 62.9 crore which is 14% higher than revenue for similar period last year. The revenue from Fulfillment and Distribution services segment was Rs. 7.9 Cr for the quarter ended December 31, 2019.

The Company's EBITDA was Rs 3.7 Cr for the quarter and Rs. 12.6 Cr for the nine months ended December 31, 2019.

The Company registered a PAT of Rs 0.9 Cr for the quarter ended December 31, 2019. The PAT for nine months ended December 31, 2019 was Rs.6.1 Cr, which is 11% higher than the PAT for similar period last year. The EPS for quarter and nine months ended December 31, 2019(not annualized) was Rs. 0.46 and Rs. 3.26 respectively.
